Course Description: This class is designed to assist early childhood teachers and childcare providers to gain a better understanding of developmentally appropriate practices in the field of early childhood education, with an emphasis on the 13 CDA Functional Areas. Participants will gain confidence and competence in their work with young children, as they reflect upon what works well and what practices they may need to change. This class is the first part of a two part series.
